REGISTER ONLINE: To register on line, fill out the entry blank (it's a word document) and send it as an attachment to Giddyupngo@att.net or send an email with horse name, rider (or riders) and classes.

MEMBERSHIP REQUIREMENTS: All exhibitors must be members of the Texas Schooling Show Association. Memberships are \$20.00 for individuals and \$25.00 for families. Dues may be paid at the show or sent to Susan McMorris, 13013 Fallwell Lane, Del Valle, TX 78617.

PRIZES: Trophy and six ribbons will be awarded in all classes (except Lead line). Championship trophy and ribbon and reserve ribbons will be awarded in each division in accordance with USEF rules.

ATTIRE: **Appropriate** attire required. Coats optional. Approved ASTM/SEI hard hats must be worn by ALL riders while mounted. This includes any area on the grounds. Numbers must be worn and be clearly visible when showing.

SCHOOLING: The course will be set and available for schooling at 7:30 a.m. on show day. The rings will be closed at 9:15 to set the courses for showing.

FACILITY CHARGE AND STALLS: Every horse present at the show will be charged a \$30.00 facility fee. Horses may be put in stalls for the day at no extra charge and bedding may be purchased.

CLASSES START AT 9:30
UNRECOGNIZED CLASSES

- 1. Lead line** - No TSSA points. Riders in this class may not ride in any other classes in this show.
- 50. Warm-up Hunter Ring 1** - No TSSA points. May be ridden at any time during the day as the first ride in the current division. To be held in Ring 1.
- 51. Warm-up Hunter Ring 2** - No TSSA points. May be ridden at any time during the day as the first ride in the current division. To be held in Ring 2.

FUTURE JUMPER DIVISION – FENCES 2’6”-2’9”

- 52. Future Jumper** - No TSSA points. Fences 2’6”-2’9”
Power and Speed - Table II sec 1.2c
- 53. Future Jumper** - No TSSA points. Fences 2’6”-2’9”
Time First Round - Table II sec 1
- 54. Future Jumper** - No TSSA points. Fences 2’6”-2’9”
Time First Jump Off - Table II sec 2b

TSSA RECOGNIZED CLASSES

CROSS RAIL HUNTER DIVISION - FENCES 18”

Open to all beginners. The course may be trotted or cantered. A horse may be used by more than one rider and each horse/rider combination may receive championship points and year end points. Riders may only cross enter into 2’Verticals Hunter and Equitation.

- 2, 3. Hunter** **4. Under Saddle (walk/trot)**

CROSS RAIL EQ. DIVISION - FENCES 18”

Same as Cross Rails Hunter.

- 5. EqOver Fences** **6. Eq Flat (walk/trot)**

VERTICALS HUNTER DIVISION - FENCES 2’

Open to all beginners. Simple fences on a course without a change of direction. Riders may only cross enter into either Cross Rail Hunter/Eq or 2’ Hunter/Eq but not both

- 7,8. Hunter** **9. Under Saddle.**

VERTICALS EQUITATION - FENCES 2’

Same as Verticals Hunter

- 10. Eq Over Fences** **11. Eq Flat**

2’ HUNTER DIVISION - FENCES 2’

Open to all horses and riders. The course will be simple fences with at least 1 change of direction.

- 12, 13. Hunter** **14. Under Saddle**

2’ EQUITATION DIVISION - FENCES 2’

Same as 2’ Hunter

- 15. Eq Over Fences** **16. Eq Flat**

2’3” HUNTER DIVISION - FENCES 2’3”

Open to all horses and riders. Same specification as 2’Hunter.

- 17, 18. Hunter** **19. Under Saddle**

2’3” EQUITATION DIVISION - FENCES 2’3”

Open to all horses and riders. Same specification as 2’Hunter.

- 20. Eq Over Fences** **21. Eq Flat**

GREEN HUNTER DIVISION - FENCES 2’6”

Open to horses in their 1st or 2nd year of showing who have not shown over fences 2’9” or higher at any show.

- 22,23. Hunter** **24. Under Saddle**

JUNIOR EQUITATION DIVISION - FENCES 2’6”

Open to riders who have not reached their 18th birthday prior to Dec 1, 2014

- 25. Eq Over Fences** **26. Eq Flat**

ADULT EQUITATION DIVISION - FENCES 2’6”

Open to riders 18 years of age and older.

OPEN HUNTER DIVISION - FENCES 2’6”

Open to all horses and riders.

WORKING HUNTER DIVISION - FENCES 2’9”

Open to all horses and riders.

I understand and agree that by entering this Competition, I am subject to Texas Schooling Show Association (TSSA) Rules, the Prize List, and local rules of the competition.

This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this Competition, the YEAR END TSSA SHOW, to the following:

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulted, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death (“Harm”).

I AGREE to release the TSSA, the Travis County Exhibition Center and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Association or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Association or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Association and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I have read the Association Rules about protective equipment; including and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Association strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child’s participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child’s behalf.
