Every entry at a Central Texas Summer Circuit show shall constitute an agreement and affirmation that the person making it, along with the owner, lessee, trainer, manager, agent, coach, driver, rider and horse: (1) Shall be subject to the constitutions and the rules of the Central Texas Hunter and Jumper Association (CHJA), and the local rules of the show; (2) that every horse, rider and/or driver is eligible as entered; (3) that the owner and any of his representatives are bound by the constitutions and rules of these associations and the show and will accept as final the decision of the Hearing Committee on any question arising under said rules and agree to hold the show, the CTHJA, their officials, directors, and employees harmless for any action taken; for that the owner, rider/driver and any of their agents and representatives agree to hold these associations, the show and their officials, directors, employees and agents harmless for any injury or loss suffered during or in connection with the show, whether or not such injury or loss resulted directly or indirectly from the negligent acts or omissions of said officials, directors employees or agents of these associations or show. Further the undersigned agrees to hold the Central Texas Summer Hunter and Jumper Show, the Decker Lake Hunter and Jumper Show, the Summer Circuit Championship Show, the Williamson County Exposition Center, Williamson County, and G&M Enterprises, their employees, and show management, harmless to lost, destroyed, or stolen property and for any injury to horses, exhibitors, and spectators before, during or after the show.

**Warning: Under Texas Law (Chapter 87, Civil Practice and Remedies Code) a farm animal professional is not liable for an injury to or the death of a participant in farm animal activities resulting from the inherent risks of farm animal activities.**
